







The “Yarn Forward” rule of origin granted by CAFTA-RD, allows free access to fabrics and clothing items made using yarn or fabrics made in the USA, C.A. or RD.



Law on Industrial and Marketing Free Zones

Companies in the textile and clothing sector can benefit from the incentives of the Industrial and Marketing Free Zone Law, since, among the benefited sectors, are production, assembly or maquila, manufacturing, processing, included in chapters 25 in ahead of the Harmonized System.

Benefits

Free admission to the free zone for the period during which it carries out its operations. →

Machinery, equipment, tools, spare parts and accessories, utensils and other belongings

Raw materials, parts, pieces, components or elements, semi-finished products, intermediate products, containers, labels, packaging, samples and patterns

Lubricants, catalysts, reagents, fuels and any other substance or material


